(iv) The Fifth NCA Notification is issued due to the paucity of candidates belonging to O.X community after the issuance of the First NCA notification vide Category Number 263/2011 (Thrissur, Palakkad – OX), Second NCA Notification vide Category Number 283/2013 (Thrissur, Palakkad – OX), Third NCA Notification vide Category Number 465/15 (Thrissur, Palakkad – OX) and thereafter the Fourth NCA Notification vide Category Number 57/17 (Thrissur, Palakkad – OX)

- (v) The candidates belonging to O.X community shall submit application for this post to any one of the districts mentioned above and shall note the name of that district against the relevant column in the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (vi)The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971.
