- i) Conventional type application will be summarily rejected. Candidates shall apply only through online application available at the Kerala Public Service Commission website www.keralapsc.gov.in
- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
- (iii) A Ranked List will be prepared for the above district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iv) The candidates belonging to above reservation community shall submit application for this post to Wayanad district where the vacancy is existing for their respective community and shall note the name of that district against the relevant column in the online application.
- (v) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- 5. Method of appointment : Direct Recruitment (From candidates belonging to above reservation community only.
- 6. Age limit 18 44. SC candidates born between 02.01.1974 and 01.01.2000 (both dates included) are eligible to apply for this post. [Including the relaxation as per Para 2 (i) of General Conditions].

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years. Please see Para (2) of the General Conditions under Part II of this notification [except Para 2 (i)].

7. Qualifications:-

- (i) A Pass in Standard VII/III Forum.
- (ii) Must posses valid Driving Licence of three years standing to drive Light Motor Vehicle with Driver's badge.
- (iii) Proficiency in Driving light Motor Vehicles which is to be proved in a Practical test (including H test) conducted by KPSC during the course of selection. Only those who passed 'H' test will alone be permitted for Road Test.

A Medical certificate regarding eye sight in Para 7 (iv)(b) from a Ophthalmologist in Government Service also will have to be produced.
- 2 The Candidates will have to furnish the full details regarding the Driving Licence and experience in driving in the relevant column (qualifications) of the application form.
- 3 Differently abled candidates are not eligible to apply for the post.
- 4 Candidates should possess a current valid Driving Licence and badge through out all the stages of selection process i.e on the last date of receipt of application, OMR/Online test and on the date of Practical Test, interview etc.
