(i) Conventional type applications will be summarily rejected. Candidates shall apply online only to www.keralapsc.gov.in

- (ii) Application submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.
- (iii) Separate Ranked list will be prepared for each districts in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force for a period of three years from the date of publication of Ranked List or until candidates are advised and appointed against the vacancies earmarked for the above communities ,but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the district whichever is earlier.

(iv) Candidates should submit application for the post to the concerned districts where the vacancy is existing for their community and shall note the name of the district against the relevant column in the application. Applications shall not be sent in violation to the above direction and if the candidate is selected his/her name will be removed from the Ranked lists and disciplinary action will be taken against him/her.

- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he or she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (vi) If there is any change in caste with respect to the entries in SSLC, then such changes are to be published in the gazette notification and the same along with the community Certificate/Non creamy layer certificate issued by the Revenue authorities, is to be produced to prove their claim in application, at the time of One Time Verification or as and when required by the commission.
- 5. Method of appointment : Direct Recruitment (from candidates belonging to SIUC Nadar and Hindu Nadar communities only)
- 6. Age Limit: 18-43. Only candidates born between 02.01.1976 and 01.01.2001 (Both dates included) are eligible to apply for this post.

7. **Qualifications**:

- 1. A degree in the concerned subject and B.Ed/BT in the concerned subject conferred or recognized by the Universities in Kerala (Concerned subjects are specified in Note II (ii) below
- 2. Must have passed the Kerala Teacher Eligiblity Test (K-TET) for this post conducted by the Government of Kerala.

Exemptions:

Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D/M.Ed. In the respective subjects are exempted from acquiring TET [G.O (P)No.145/16/G. Edn. Dated 30.8.2016 and G.O(P)No.206/16/G.Edn. Dated 8.12.2016]

- Note (I):- M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala.
- Note (II):- I) Diploma in Rural Service awarded by the National Council for Rural Higher Education will be treated as equivalent to Degree for the above purpose ii)The applicants should have taken Botany or Zoology or Home Science or Micro Biology as Main subjects for graduation or post graduation.

iii) The candidates who have acquired B.Sc.Ed in Chemistry - Botany - Zoology stream conducted by the Regional Institute of Education Mysore of NCERT are also eligible to apply for the post [G.O(P)No.117/13/G.Edn dated 30.3.2013]

iv)B.Ed in life science awarded by any of the Universities in Kerala through a regular course of study or B.Ed in Life science awarded by Universities outside Kerala through a regular course of study which is recognised as equivalent to B.Ed in Natural Science by any of the Universities in Kerala will also be accepted as sufficient training qualification for the post. [G.O.(MS) No. 46/2011/G.Edn dated 22/2/2011, G.O(MS)No.145/2012/G.Edn dated 9.5.2012.

- v) B.Sc Biotechnology along with B.Ed-Natural Science will be considered as one of the qualifications for the post.(GO(Ms) No:113/14/GEdn dtd 19/6/2014).
- vi)B.Sc Family and Community Science degree of MG University will be considered for the post.(GO Rt No: 4015/2018/GEdn dtd 5.10. 2018).
- Vii) If there is a written (Descriptive/OMR)test the question paper for the written test will be in Malayalam. The candidates should answer the the questions in Malayalam. In the case of OMR Answer script, answers are to be marked as instructed.
- Viii) Candidates claiming equivalent qualification should produce relevant Government Orders during verification to prove that the qualification claimed is equivalent to the prescribed qualification for the post.

NB: Rule 10(a) (ii) of Part II of the KS&SSR will be applicable for this post.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term `Jawans'. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).
- (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975).
- (iii) Teachers of the Government Primary and Nursery Schools who are graduates and are otherwise qualified will be exempted from upper age limit (G.O (Ms) No 185/70/Edn dated 18.4.1970 and G.O (Ms) No 466/70/Edn dt 11.11.1970). They should produce proper certificates from authorities concerned as and when required by the Commission.

Note:- The candidates who are eligible for the above preferences or concessions in upper age limit or concessions by virtue of any of the reason mentioned in Para 2 of the General Condition (except para 2 (i)) should claim the same through the "weightage and preferences" link provided in their One Time Registration Profile and give details in the space provided. The applications of candidates who are eligible for concession in upper age limit and who do not claim the same, are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (see para 2 of General Conditions).

10. Mode of Sending Application:
