Note:- **(i)** Conventional type applications will be summarily rejected. Candidates shall apply online only by One Time Registration to www.keralapsc.gov.in.

- (ii) Separate Ranked List will be prepared for each district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he or she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. But as per the GO(P) No 12/96/P&ARD dated 16.3.1996 the condition of 5 years service is not applicable for transfer to Idukki, Wayanad and Kasaragod districts. The concession will be available only for getting transfer to these districts but not for getting transfer out of these districts. And this condition will be granted only once in the career of a Govt Servant. Candidates already in Government service holding the same

- post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (iv) Candidates should submit their application for this post to the concerned district, where the vacancy is existing and should note the name of that District against the relevant column of the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (v) In case of change in Caste/Community noted in the SSLC Book, candidates must claim their original Caste/Community in the application and shall produce Community Certificate/Non Creamy Layer Certificate as the case may be issued by the Revenue Authorities and the Gazette Notification publishing the change of Caste/Community at the time of OTR Verification for selection to the above post.

A title of Oriental learning in Sanskrit awarded or recognized by any one of the Universities in Kerala.

OR

Oriental School leaving certificate (Sanskrit) issued by Government of Kerala.

OR

A Pass in the preliminary Examination in Sanskrit conducted by any one of the Universities in Kerala.

OR

A Pass in the Pre-university or Pre-degree Examinations from Sanskrit Colleges affiliated to the Universities in Kerala.

A Pass in Sanskrit Teacher's examination conduced by the Commissioner for

A Pass in the Pre-degree Examination with Sanskrit (Sahithya) and Sanskrit (Sasthra) as optional subjects conducted by the Arts or Science Colleges affiliated to the Universities in Kerala.

OR

A pass in plus 2 course conducted by the Kerala Higher Secondary Directorate with Sanskrit (Sahithya), Sanskrit (Sasthra), History and Economics as combination.

3) Must have passed the Kerala Teacher Eligibility Test (K-TET) for this post conducted by the Government of Kerala

Exemption: Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D/M.Ed. in the respective subjects are exempted from acquiring TET (G.O. (P) No. 145/16/G.Edn. Dated 30.08.2016 and G.O.(P)No.206/16/G.Edn. Dated 08.12.2016).

Note:- M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala.

- **NB:** (i) Rule 10(a) (ii) of Part II of the KS&SSR will be applicable for this post.
- **(ii)** Applications of candidates who have claimed qualification equivalent to thoseprescribed in the Gazette Notification for the post will be considered equivalent only if they produce Government Orders to prove equivalency at the time of verification.

(3) <u>SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT</u>

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term `Jawans'. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).
- **(ii)** Laboratory Attenders in the departmental High Schools in the State who have rendered at least 5 years satisfactory service and who possess the prescribed qualification will be exempted from age limit. They should produce proper certificates from the headmaster of the school specifying the date of commencement of their service and the total service put in by them as and when required by the Commission. The candidates who claim

exemption on this basis will be considered only against vacancies to be filled up by open competition on the basis of merit alone (G.O (MS) No.315/62/Edn. Dated 14.05.1962).

(iii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975 and GO(MS) No.50/70/PD dtd 12.02.1970).

Note:- The candidates who are eligible for the above preferences or concessions by virtue of any of the reason mentioned in Para 2 of the General Condition should claim the same through the "weightage and preferences" link provided in their One Time Registration Profile and give details in the space provided. The applications of candidates who are eligible for concession in upper age limit and who do not claim the same, are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (see para 2 of General Conditions).

10. Mode of Sending Application :

Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered shall apply by logging in to their profile using their user ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view the details in their profile by clicking the link 'Registration Card' in their profile. A print out of the same can be taken if needed. Candidates are responsible for the correctness of the personal information and secrecy of password. Before final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Application once submitted is provisional and cannot be deleted or altered after submission. Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, community, Age, etc., have to be produced as and when called for. "Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile".

- **12.** If a Written Test/OMR/Online Examination is conducted as a part of this selection, Candidates shall submit a confirmation for writing the examination through their 'One Time Registration' Profile. Such candidates alone can generate and download

the Admission Ticket in the last 15 days till the date of test. The applications of the candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Ticket will be published in the examination calander itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Appropriate disciplinary action as per KPSC Rules of Procedure, Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
