There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view the details in their profile by clicking the link 'Registration Card' in their profile. A print out of the same can be taken if needed. Candidates are responsible for the correctness personal information and secrecy of password.
